The classroom-based activity will include structured learning which will be underpinned with relevant assessments both practical and written to demonstrate both understanding and application of knowledge in each key area of gas safety and/or related activities such as safe isolation, basic health and safety etc. At the end of the course, learner should be at a level of competence to undertake their Accredited Certification Scheme (ACS) core Domestic Gas Safety Assessments and any work-related appliances that may be required.

Each part of the course is ideal for new entrants and career changers who want to learn practical skills from seasoned professionals. Whether you're prepping for a full gas career or just want to build solid, employable plumbing knowledge, this course delivers.

Step 3; “On-site” MLP Training (Portfolio)

Duration: On-site training should be a minimum of 18 weeks under direct supervision of gas safe registered engineer(s). Supporting evidence (such as photographs, job sheets, copies of commissioning sheets and safety records etc) must be of sufficient breadth and quality for this to be achieved. Upon successful completion of in-centre training, as part of the managed learning programme and prior to sitting the ACS assessment, you require to complete an '**On-site**' **Portfolio of Evidence**. If you encounter any difficulty with your own arrangements for Portfolio service, we may recommend a mentor. (Gas engineer may charge for this service, price on application, if any).

- ❖ Upon successful completion of Summative assessments and on-site portfolio (and approved by one of our assessors), you are issued a **Pathway to Gas MLP Certificate** by BlueFlame Certification covering Core Gas Safety Competency and Domestic appliances (as applicable to the route taken). Now you are eligible to apply for (Step 3) ACS Domestic core gas safety Initial assessment.
- ❖ Upon successful completion of assessments, **if applicable** learners will also receive **Unvented Hot Water Storage Systems (UVHW-G3), & Water Regulations** certificates issued by BlueFlame Certification.

Step 4; ACS Domestic Gas Safety (CCN1) Assessment (Initial)

Duration: 3-4 Days: You are assessed on theory (Open book exam with multiple choice questions) and practical knowledge. On successful completion of assessment, learner will be issued a certificate for Core **CCN1** and **One** Appliance (CENWAT, CKR1, HTR1, MET1), or subject to your training certificate (Additional Appliances can be undertaken if included in MLP Training). **Candidates are now eligible to apply for Gas Safe Registration. ***

*We usually recommended All MLP or Initial ACS Assessment Candidates to take the Plumbing course to assist their ACS, Portfolios, & general introduction to the Gas & Plumbing industries.
